THE PERKINS SCHOOL OF THEOLOGY

For a century, the Perkins School of Theology has been one of the leading theological schools in the nation, having trained thousands of ministers, scholars, and church leaders, serving around the world. The primary mission of the School, as a community devoted to theological study and teaching in the service of the church of Jesus Christ, is



to prepare women and men for faithful leadership in Christian ministry. Perkins offers Master of Divinity, Master of Arts in Ministry, Master of Theological Studies, Master of Theology, Doctor of Pastoral Music, and Doctor of Ministry degrees. Additionally, Master of Arts and Doctor of Philosophy degrees in Religious Studies are offered in conjunction with the Dedman College of Humanities and Sciences, and the Master of Sacred Music is offered in cooperation with the Meadows School of the Arts. The School, with its extension in Houston, has 37 faculty; its approximately 350 students come from a variety of religious traditions and backgrounds. Perkins prides itself on its ecumenical and interfaith approach.

THE REGION

With a population exceeding 6.8 million, greater Dallas is the fourth-largest and fifth-most diverse metropolitan area in the nation. It offers access to all of the cultural, athletic, and recreational opportunities of a major urban center as well as an enviably low cost of living. North Texas is home to nearly 20 *Fortune* 500 companies and one of



the world's busiest international airports. Dallas boasts the nation's largest urban arts district, which consists of world class museums and a luminous cluster of performing arts spaces, highlighted by the Winspear Opera House, described by Opera magazine as America's

finest. With the Trinity River, White Rock Lake, almost 400 parks, and over 125 miles of urban hiking and biking trails, the city provides abundant opportunities to enjoy the outdoors. Because of its commitment to environmental sustainability, Dallas has been named one of the Greenest Cities in the world. SMU students and faculty utilize the Dallas metropolitan area as an extension of the classroom, characterized by engaged learning projects and community partnerships. THE UNIVERSITY

SMU is a nationally ranked private university with seven degree-granting schools (http://www.smu.edu/AboutSMU/Administration). The University's 11,000 students, 42% of whom are enrolled in graduate studies, benefit from small classes (11:1 student/faculty ratio), leadership opportunities, international study, and innovative academic programs. The University has more than 700 faculty members and library holdings of almost 4 million volumes, and offers doctoral degrees in various fields of the humanities, social sciences, natural sciences, engineering, and professional

disciplines. The national ranking of the undergraduate programs and the quality of the student population are on the rise, reflected in part by the composite SAT scores for entering students, which have increased by more than 150 points in the last thirteen years, so that the average now exceeds 1300.



SMU is located in the heart of Dallas, in the beautiful residential Park Cities area, with additional campuses in Plano, Texas, and Taos, New Mexico. Perkins offers extension classes in Houston as already mentioned. The University's current endowment has a market value of \$1.4 billion, augmented by its centennial capital campaign of \$750 million, which – after its tremendous initial success – was raised to \$1 billion. SMU is nearing this revised goal, including 110 endowed chairs, and has already surpassed its goal of 500 new student scholarships.

The University was founded 100 years ago as a partnership between the Methodist church and the people of Dallas and has been shaped ever since by a commitment to academic freedom and open inquiry as well as the entrepreneurial spirit of the region. Dallas' position as an international business and cultural center has enhanced the University's ability to attract and retain top faculty and students, making SMU a nationally prominent university with a global reach.

Campaign gifts are providing funds for 511 scholarships; 40 academic programs, including schools, departments, institutes and centers; 38 endowed faculty positions; and seven major capital projects.

Athletics

- SMU competes in the American Athletic Conference at the highest level of intercollegiate athletics Division I, Football Bowl Subdivision.
- SMU sponsors 17 sports and had 10 teams compete in post-season play in 2013-14.

Academic Offerings

Dedman College of Humanities and Sciences

<u>Dedman College</u> is SMU's most diverse academic unit. It is home to the humanities and social, natural and mathematical sciences – disciplines that are the core of higher education. The College offers 38 undergraduate majors and 55 minors, plus numerous interdisciplinary programs. The College also provides 17 master's programs and 14 doctoral degree programs.



Dedman College promotes academic discovery through its interdisciplinary centers and institutes, including the John Goodwin Tower Center for Political Studies; Dedman College Interdisciplinary Institute; Center for Drug Discovery, Design and Delivery; and the Embrey Human Rights Program. Research throughout the College addresses issues of local, national and global importance, including the development of new cancer therapies, prevention of domestic violence and pressing public policy matters. Each of the centers and institutes allows students to put their ideas into action through engaged learning activities

beyond the classroom.

Cox School of Business

The Cox School equips students with the knowledge, skills and experience needed to become business leaders. Major publications, including Bloomberg Businessweek, The Economist and Forbes, rank SMU Cox among the top business schools nationally and globally. The Cox School offers the Bachelor of Business Administration with majors in accounting, finance, financial consulting, general business, management, marketing, real estate, finance, risk management and insurance; Full-Time, Executive and Professional (part-time) Master of Business Administration; and Master of Science degrees in accounting, business analytics, finance, management and sport management (with



the Simmons School).

Among the Cox School's advantages is its location in Dallas, ranked by Forbes.com as "the #1 best city for good jobs." Cox has forged strong relationships with leading companies and influential business leaders in the area and has been recognized in The Economist as one of the top schools worldwide for networking potential. The Cox School offers international immersion experiences for Full-time, Professional and Executive MBA students as part of its Global Leadership Program. All Cox students have access to 15 exchange partnerships with schools around the world.

Meadows School of the Arts

The <u>Meadows School</u> prepares students to lead professional careers in the arts and communications and provides opportunities for all SMU students to grow in appreciation of the arts. A leader in innovative community engagement programs, Meadows challenges students to make a difference locally and globally by developing connections between arts entrepreneurship and social change. The Meadows School provides bachelor's and master's degrees offered through 11 study areas: Temerlin Advertising Institute, Art, Art History (also offering a Ph.D.), Arts Management and



Arts Entrepreneurship, Communication Studies, Creative Computing, Dance, Film and Media Arts, Journalism, Music and Theatre.

The National Center for Arts Research analyzes the largest database of arts research ever assembled to provide datadriven insights into challenges facing U.S. arts organizations. The Meadows Prize is an international arts residency awarded annually to up to two pioneering artists in a Meadows discipline, who work with students on campus. The school also includes the renowned Meadows Museum (http://www.meadowsmuseumdallas.org/).

Bobby B. Lyle School of Engineering

The <u>Lyle School</u> prepares today's engineering students to be tomorrow's innovators equipped with both technical and leadership skills. The Lyle School provides bachelor's, master's and doctoral degrees offered through departments of Civil and Environmental Engineering; Computer Science and Engineering; Electrical Engineering; Engineering Management, Information and Systems; and Mechanical Engineering.


Lyle students participate in programs in the unique Deason Innovation Gym, designed to support and encourage innovation in all forms. The Hart Center for Engineering Leadership helps students develop nontechnical skills to prepare them for leadership in diverse technical fields. The Caruth Institute for Engineering Education develops new methodologies for incorporating engineering education into K-12 schools. The Hunter and Stephanie Hunt Institute for Engineering and Humanity combines technological innovation with business expertise to address global poverty.



SMU's high-performance engineering complex includes LEED gold-certified buildings and advanced research facilities.

Dedman School of Law

The <u>Dedman School of Law</u> offers students a personalized legal education in a community of distinguished scholars. The Dedman School of Law offers Juris Doctor (day and evening J.D. programs), Master of Laws (LL.M.) and Doctor of Juridical Science (S.J.D.). The Master of Laws for foreign law school graduates was among the first in the country and has graduated more than 1,400 lawyers from 80 countries. The J.D./M.B.A. is offered jointly with Cox School of Business. The J.D./M.A. in economics is





Dedman School of Law publishes five law journals and operates six legal clinics serving diverse community needs with free or low-cost legal service. Pro bono legal service is a requirement for graduation. Dedman Law ranks 20th nationally, among the 201 ABA accredited law schools, in placement for long-term, full-time jobs requiring bar passage.

Annette Caldwell Simmons School of Education and Human Development

The <u>Simmons School</u> prepares exemplary professionals and advances knowledge through evidence-based research. The Simmons School offers undergraduate teacher certification; a bachelor's degree in applied physiology and sport management; graduate certifications and specializations in literacy education, bilingual education, English as a Second Language (ESL) and Science, Technology, Engineering, and Mathematics (STEM); a master's degree in education, bilingual education, educational

leadership, higher education, special education, reading and writing, counseling, dispute resolution, liberal studies, and sport management; and a Ph.D. in education.

The Simmons School is involved with many research and community programs, encompassing: the Center on Research and Evaluation; Institute for Evidence-Based Education; Gifted Students Institute; Applied Physiology and Biomechanics Laboratory; Locomotor Performance Laboratory; Research in Math Education; the Center for Child and Community Development; the Center for Family Counseling; Diagnostic Center for Dyslexia and




Related Disorders; College Access; Community Counseling Centers; Mediation Services; the Center on Communities and Education; Creative Writing; and academic enrichment programs for youth.

The Perkins School of Theology

History

The Perkins School of Theology has been part of Southern Methodist University since the university's founding, growing out of the work of a commission led by Bishop James Atkins of the Methodist Episcopal Church, South to establish a theological school west of the Mississippi River. Dr. E.D. Mouzon, dean of the Theological Department of Southwestern University and later bishop, became the first dean in 1914. With the opening of the University in the following year, the School of Theology began its work as the church's official theological school for the western half of the United States. When ownership of the University was vested in the South Central Jurisdiction of The Methodist Church at the Uniting Conference of 1939, the School of Theology became the official theological school of that jurisdiction.



Beginning in 1945, the University received a series of large gifts from Joe J. Perkins and Lois Craddock Perkins of Wichita Falls, Texas, which made possible the campus relocation and expansion of the school of theology and provided a major endowment for its support. The generosity of the Perkins family has continued for three generations from the families of Elizabeth Perkins Prothro and her late husband Charles, and Caren Harvey Prothro and her late husband C. Vincent Prothro, as well as from the family of



Kay Yeager and her husband Frank. The establishment of Bridwell Library was made possible through a founding gift from Joseph S. Bridwell of Wichita Falls and his daughter, Margaret Bridwell Bowdle in the late 1940s. The library continues to benefit from the munificence of the Bridwell Foundation.

Programs and Curricula

Perkins offers a range of degree programs, allowing students to follow a path best suited to his or her vocational direction. Many of these programs are structured so as to allow a concentration in a particular area of interest.

The Master of Divinity (M.Div.) degree is designed primarily for students who plan to be ordained clergy and serve in Word, sacrament, service and order. It may also equip a person for other specialized ministries.

The Master of Arts in
Ministry (M.A.M.) degree program is
intended to prepare persons for
specialized church ministry. The goal
of the program is to increase
students' knowledge about the
church and its ministries and to foster
their ability to work meaningfully
and creatively in a specialized area of
church ministry. The five specialized
ministry tracks include Christian



Education, Urban Ministry, Theology and Social Justice, Christian Spirituality and Evangelism and Mission.



The Master of Sacred Music (M.S.M.) degree program is jointly sponsored by Perkins School of Theology and the Division of Music of Meadows School of the Arts as preparation for professional music leadership in the church and, if one chooses, ordination as deacon.

The Master of Theological Studies (M.T.S.) degree program is designed to provide a basic understanding of the theological disciplines as a foundation for further graduate study, for enhancement of lay leadership roles or for personal enrichment.

The Master of Theology (Th.M.) degree program is designed for students to enhance the practice of ministry through advanced study of a particular theological or pastoral discipline; to engage in scholarly examination of a specific aspect of the Christian religion/traditions or function of Christian ministry; or to prepare for more advanced study at the doctoral level.

The Doctor of Ministry (D.Min.) degree provides the opportunity for advanced study that integrates theological reflection and ministerial practice with a contextual focus for people in professional ministry within the church.

The Doctor of Pastoral Music (D.P.M.) degree program is designed for experienced church musicians who have achieved a Master of Sacred Music degree or its equivalent and who are devoted to increasing their effectiveness in and broadening their vision of the pastoral dimensions of music ministry.

The degrees of Doctor of
Philosophy (Ph.D.) and Master of
Arts (M.A.) in Religious Studies are
offered by the Graduate Program in
Religious Studies in SMU's Dedman
College. The primary goal of both degree
programs is to prepare persons for
professional careers as teacher-scholars in
colleges, universities, and schools of
theology. The MA degree program also



aims to accommodate the qualified nonprofessional student interested in advanced work in religious studies within the context of the liberal arts and sciences.

Bridwell Library

Bridwell Library at Perkins School of Theology includes a full range of theological, biblical, and historical materials relating to the development of Christianity. In addition to the material available in the basic lending collection of the library, which is strong in Methodist materials, Bridwell Library contains a number of special collections that are especially valuable for the study of topics related specifically to the background, rise, development, and present status of Methodism.



With total holdings exceeding 370,000 volumes, Bridwell Library's Special Collections contain over 50,000 printed books dating from the fifteenth to the twentieth century. Most of the printed works in these holdings, often in first and early editions, are in the fields of theology, church history, scripture, liturgy, and philosophy. Many of these editions are distinguished by fine illustration

and typography, notable provenances, and historically significant bindings. Holdings also include manuscript correspondence by John Wesley and other important figures in early Methodism, archival collections of American Methodism and private presses, and a small group of Medieval and Renaissance manuscripts.

Bridwell Library is among the best theological libraries in the nation and is one of the many academic resources available at Perkins. Bridwell, along with the renowned faculty, is at the core of Perkins' reputation of academic excellence as a leader in theological education.

Responsibilities of the Dean

The Dean is responsible for all aspects of the School's activities including the administration of academic programs and procedures; the recruitment, development, and evaluation of faculty and staff; the management of the School's fiscal resources; the

development of new funding sources; and the representation of the School of Theology within the University, The United Methodist Church, and the broader global community while honoring its particular geographical and cultural setting in the southwestern United States.



Qualifications

Successful candidates must be tenurable in the Perkins School of Theology at the rank of Professor and must be a discerning evaluator of theological teaching and scholarship. She or he must understand the nature of current trends in theological education, have a commitment to Perkins' role in the University, church, and world, and possess a creative vision for the School's future. The candidate must be a United Methodist thoroughly acquainted with the traditions, structures, and practices of The United



Methodist Church; ordination as an elder in The United Methodist Church is preferable. Demonstrated achievement or potential for success in faculty development, fundraising, student recruitment, strategic and fiscal planning, and external relations is required. The University seeks an individual who is able to exercise leadership, to sustain a community, and to relate to diverse constituencies.
