	Alcohol and drugs are prohibited on the Taos campus. I may be removed from the program if I violate this policy or any violation of the SMU Student Code of Conduct.

	I will respect and not tamper with the property of others, including, but not limited to, the property of SMU, or any person, lodging, restaurants or sites visited during my participation in the Program.

	I will refrain from holding or participating in parties and other loud activities at night, so as not to encourage unwelcome guests, or disturb other residents and the neighboring community.
	Daytime guests are allowed on campus only with permission from the Executive Director or Program Coordinator. Overnight guests are prohibited.
	I will notify the SMU-in-Taos Student Affairs Coordinator of any travel plans before I depart on independent trips. I will also provide an address where I may be contacted in case of emergency.
