### ► Family Immigration Law:

The law firm of Coleman Jackson, P.C. located in Dallas, Texas focuses on immigration, deportation and removal, nationality and consular processing matters in the United States and worldwide, especially, in Mexico, Central America, South America, Ethiopia and Eretria, and other Spanish countries, or Latino cultures, and other points in Africa. Families, churches and other entities routinely come to Coleman Jackson, P.C. for their immigration needs, such as, petitioning for a family member to immigrate to the United States, including getting a green card for a spouse, child, parent or sibling. Under the Immigration and Nationality Laws (INA) there might be certain benefits for a United States Citizen (USC) or Legal Permanent Resident (individuals with green cards) to help reunite their family. We help apply for various types of visas depending upon the facts and circumstances of each immigrant situation. In addition to helping families with various types of visas, we also help entities to bring in qualified workers, such as skilled workers or religious workers. When it comes time to adjust status or to become a United States Citizen, we help immigrants in adjustment of status process (known as getting a green card) and we help immigrants applying to become a United States Citizen through naturalization. Coleman Jackson, P.C. also represents self petitioners, such as, those who are self-petitioning under the Violence against Women Act (VAWA). VAWA is humanitarian relief under the United States Immigration laws designed to protect abused spouses and children. A VAWA petition can be filed by an abused male or female spouse or child of a United States Citizen or Green Card Holder. Aliens who are victims of crime may be entitled to selfpetition by use of a U visa. Visa petitions and immigration law is complicated. It is very important that petitions, humanitarian waivers and other immigration paper work be completed accurately with appropriate supporting documentation to avoid frustrating delays and unnecessary denials. At Coleman Jackson, P.C., you will receive quality personal legal services, committed to helping you achieve your goals. If you, your employer or family are seeking immigration counsel, contact Coleman Jackson, P.C. You should also contact an immigration lawyer when you or your alien relatives receive a Notice to Appear (NTA). An NTA is the initiation of removal proceedings in Immigration Court when a person is arrested and detained by immigration officials or local police on the suspicion of not having lawful immigration status. Often the alien is arrested first by local law enforcement or Immigration Customs Enforcement (ICE) officers and then given a Notice to Appear. The alien whom the NTA is issued is the respondent. Arrest and detention and the issuance of the Notice to Appear is the initial phases of the Immigration Court Proceedings; and typically the next step is an immigration appearance bond hearing in Immigration Court. Sometimes an alien can be placed in removal proceedings as the result of tax issues. For example, The United States Supreme Court ruled on February 21, 2012 in Kawashima v Holder that violations of 26 U.S.C. §§7206(1) and (2) are crimes "involving fraud or deceit" under 8 U.S.C. §1101(a) (43)(M)9i) and are therefore aggravated felonies as that term is defined in the Immigration and Nationality Act, 8 U.S.C. §1101 et seq, when the loss to the Government exceeds \$10,000. Again if you or your alien relative is arrested and detained, receives a NTA, the law firm of Coleman Jackson, P.C. can represent aliens in Immigration Court and before the Board of Immigration Appeals

## Business Immigration Law:

## ► Tax & Estate Planning Law:

We counsel taxpayers in both individual tax matters as well as taxpayers who are caught up in tax disputes involving their employer, corporation, or other business entity under Internal Revenue Code 6672, when a company fails to pay employment and unemployment taxes. When a business fails to pay employment and unemployment taxes, typically the IRS or taxing authority can assess a penalty against those persons responsible for collecting the taxes at the company and paying the tax to the government. This penalty is called the Trust Fund Recovery Penalty. Similar trust fund penalties may apply at the State level with respect to a business collecting and paying sales taxes to the State of Texas that business collects from its customers. The tax law office of Coleman Jackson, P.C. can help taxpayers with trust fund recovery penalty problems, as well as with tax disputes involving independent contractors and employees misclassification issues. Classification of workers is a very important tax issue because whether a worker is classified as an employee or independent contractor determines who should pay federal income tax, social security tax, Medicare tax and other worker related taxes. The tax law firm of Coleman Jackson, P.C. helps employers with worker classification issues. U.S. persons with financial accounts and assets in foreign countries must report these assets to the United States government annually. Failure to file information returns or make appropriate disclosures under the FBAR and FATCA could subject a taxpayer

to additional penalties and investigation by the Criminal Investigation Division of the IRS. The tax law office of Coleman Jackson, P.C. represents immigrants and other U.S. persons involved in FBAR and FATCA tax disputes. We also represent aliens placed in deportation and removal proceedings based on tax fraud convictions. Ordinarily, before a taxing unit can collect a tax liability there must be a tax assessment and demand for payment. If the taxpayer disputes the reasonableness of the assessment or disputes the amount of the assessment, the taxpayer may be able to negotiate with the tax examining unit, tax auditor or tax appeals unit to attempt to resolve the tax dispute without litigation. If the tax dispute is not resolved at the administrative level, the taxpayer may be able to file suit in United States Tax Court, Federal Court of Claims or United States District Court. And if State taxing authorities are involved, unresolved State tax disputes are subject to judicial review in the appropriate State District Courts. Again, in any tax controversy, taxpayers ordinarily should attempt to resolve the tax dispute at the audit or administrative appeals level if at all possible. It is important to hire a tax attorney early in the tax dispute. The law firm of Coleman Jackson, P.C. represents taxpayers at the audit and appeals level as well as in the United States Tax Court, Federal Court of Claims, U.S. District Court and the State Courts in Texas.
