
SMU Pedestrian Systems Usage Map Protocols



- This map details the Paved Pedestrian Malls which are off limits to any unauthorized vehicular use.
- The areas in **blue** are for **Limited Use Only** such as emergency vehicles, special event vendors, catering services, and service trucks with prior written approval (Use of Campus Grounds Request Form).
- The areas in **red** are for **Emergency Use Only**.
- Street legal and non-street legal utility and golf carts are permitted on both red and blue areas.
- Non-street legal utility and golf carts are permitted on SMU owned roads only (the **yellow** areas), because they are not licensed for City Streets.
- Emergency vehicles are defined as, but are not limited to, Police and other Law Enforcement, Fire Trucks, Ambulance, EMS, Rescue/Recovery, Hazardous Material and Public Utility.
- Parking is governed by markers and traffic signs and is permitted only in areas clearly identified for parking.
- All delivery trucks must use the designated driveways and loading zones. This includes catering, shipping companies (FedEx, UPS, DHL, US Postal, etc.), and maintenance trucks.
- The absence of No Parking signs does not imply that parking is allowed.
- Areas of construction access will be handled on a case by case basis.

Paved Pedestrian Mall

- The malls are intended to be used by pedestrians and not thoroughfares for vehicles or temporary parking for contractors, vendors, deliveries, or pickups. Vehicles are defined as cars, trucks, vans, busses, and motorcycles.
- Although street legal and non-street legal utility carts are allowed on Paved Pedestrian Malls, they must give the right-of-way to pedestrians.
- The exception to allowing trucks on malls is the setup of tents for selected events with prior written approval from Facility Services (Use of Campus Grounds Request Form).
- Employees of SMU are not permitted to drive their personal vehicles on any Paved Pedestrian Mall.
- Contractors and vendors are not allowed to drive or park their vehicles on Paved Pedestrian Malls.
- Busses of any size are not allowed to drive or park on Paved Pedestrian Malls.
- Guests to the campus are not allowed to drive or park on Paved Pedestrian Malls
- Short Notice Access for the media will be allowed on preapproved paved areas without the need for the Use of Campus Grounds Request form.

Sidewalks

- Sidewalks are intended to be used by pedestrians and not thoroughfares for vehicles or temporary parking for contractors, vendors, deliveries, or pickups. Vehicles are defined as cars, trucks, vans, busses, and motorcycles.
- Although street legal and non-street legal utility carts are allowed on selected sidewalks, they must give the right-of-way to pedestrians.
- All sidewalks are divided into three categories: primary those 10ft. wide and over; secondary those between 5 and 10 ft. wide; and tertiary 5ft wide and under.
- No motorized vehicle is allowed on sidewalks less than 5ft. wide.
- Two-passenger (street legal and non-street legal) utility carts are allowed on tertiary, secondary and primary sidewalks.
- Multi-passenger (street legal and non-street legal) carts, 4 and more, are allowed on secondary and primary sidewalks only.
- The only exception to vehicles being allowed on primary sidewalks is when a support truck is required to conduct emergency work; trucks needing to deliver and set up tents on the Main Quad during special events; and for any emergency vehicles.
- Employees of SMU are not permitted to drive their personal vehicles on any sidewalk.
- Contractors/vendors are not allowed to drive or park their vehicles on sidewalks.
- Busses of any size are not allowed to drive or park on sidewalks.

Utility Cart Parking

Street legal and non-street legal utility carts are not allowed to park in the following locations (these are subject to change anytime with written notice):

- SMU private roads
- In front of exits of buildings
- Landscape or grass areas
- Path of pedestrian travel
- Public right-of-ways (non-SMU private roads)
- Within ten feet (10') of fire hydrants
- In designated fire lanes
- Handicap parking spaces
- Service Vehicles Only" parking spaces
- Metered parking spaces
- Marked parking in Garages and surface parking lots
- Loading docks
- Under Trees
- Not within fifteen feet of a cross walk (marked or unmarked)
