- 2. To initiate your interest in candidacy by returning the application and the nonrefundable \$50 application fee by fax, mail or email.
- To submit an unofficial transcript or photocopy of diploma via fax, mail or email.
   Transcripts from a college or university outside of the U.S. must be translated and evaluated.

Disclosures in the affirmative to the following questions will not necessarily result in rejection of an application for admission. Failure to explain an affirmative response to any of the following questions may result in cessation of review of your application. Failure to disclose such a record, if it exists, and to explain the record honestly and fully, may result in revocation of your admission or dismissal from the University. The University reserves the right to request additional documentation from you.

- 1. Are you currently under indictment for any crime?
- 2. Have you ever been convicted of any offense, placed on probation or granted deferred adjudication or any type of pretrial diversion?
- 3. Have you ever been dishonorably discharged or dishonorably dismissed from the armed forces?
