RESEARCH AGENDA:

The underlying theme of my research agenda is investigation of key psychological factors that influence skill development and personal performance improvement. The principal pursuit of this theme has been a systematic research program that has investigated how goal orientation (achievement motivation) preferences influence the use of self-management activities such as goal setting, feedback seeking, and planning to enhance personal performance and success. A second research agenda examines how a leader's implicit theory about ability (a fixed or a growth mindset) influences a leader's self-management and management of others.
