# Where do I start?

Interested SMU undergraduate economics majors should consult with their Undergraduate Advisor for approval before the end of the Spring semester of their Sophomore year (or after completing 60 credits hours, including transfer and test credits). Approved candidates should work closely with the Undergraduate and Graduate Advisors to plan the appropriate curriculum path.

Students need certain prerequisites to be eligible for the program. The Undergraduate Advisor will help you decide if this is a good option for you.

### How does it work?

Students who are enrolled in the Economics B.A. or B.S. program and are approved 4+1 candidates must apply to the M.A. program in their senior year. If admitted, then they are eligible to take courses in their final year.

Please note that students cannot take more than 30 graduate credits in this final year.

Once you complete the requirements for your Bachelor's degree, you're ready to move on to your Master's, which has already started!
