From the Director

Dear Friends,

They say time passes quickly when you are having fun. At the risk of revealing the dirty little secret that I consider mine the best job in the world—and thus guite a bit of fun—I'm nonetheless amazed at how fast our first ten years have flown by. A decade ago we were little more than an idea. Ten years later we've produced 22 post-doctoral fellows, who themselves have produced nearly a dozen published books with more on the way. We've seen them gain tenure-track and other permanent positions in the vast arena of academic and public history. We've created from scratch a new PhD program in American History that this upcoming year will reach double digits in students. We've done 140-plus oral histories for our collective memory project with no sign of slowing; we've hosted 12 local high school students and five SMU undergraduates as interns. We've taken friends and students to Pearl Harbor, Normandy Beach, and the Berlin Wall, and hosted more than 150 events including 10 large conferences. And oh yes, two podcasts, a book prize, faculty research and writing fellowships, and teacher institutes

where we've instructed more than 500 K-12 educators. It's been an exhausting, fulfilling, and yes, enjoyable ride. Thanks in no small measure to your ongoing support, here's to another decade!





Ashlyn Hand is a CPH fellow writing a book on religious freedom and US foreign policy. As a PhD student at UT (Austin), she worked with Dr. Inboden.



This book recounts how Ronald Reagan and his national security team confronted the Soviets, reduced the nuclear threat, won the Cold War, and supported freedom.




The inaugural CPH Book Prize for first-time authors is going to **Fritz Bartel** for his book *The Triumph of Broken Promises: The End of the Cold War and the Rise of Neoliberalism* (Harvard University Press, 2022). Dr. Bartel received his PhD from Cornell University and is an assistant professor at the Bush School of Government and Public Policy at Texas A&M. He will deliver the Book Prize Lecture at SMU in early 2024.

MAKING History

CPH intern Tamal Pilla sat down with Dr. Brian Franklin to discuss *Hand-off* and the making of the Transition Project.

What is the Transition Project, and how does it relate to Hand-off?

Well, *Hand-off* is the name of the book that was just published by Stephen Hadley, the former national security adviser, and some of his colleagues. The project that we've developed, alongside that and to expand on that book, is called the Transition. And that project features over 700 documents produced by members of the National Security Council under George W. Bush as they were handing off critical national security information to their incoming successors in the Obama administration. So what it's really about is providing firsthand documentation about how one presidential



administration attempted to at least set up the next administration with some base of knowledge for where they'd be working from.

(2: How did this project get started and what is its status right now?

This project really started from their idea for the book. Once we heard from them in the spring of 2022, we were in touch with them because they had many, many more memos and supporting documents that they had produced as part of that research that were not going in the book. So the book is a portion of the document part of the memos, about two dozen, along with some commentary. The website is all 700+ of the memos along with all the attached documents that they gave with the memos, all in one spot. The website has launched, and you can find all of the above information and more to come as we declassify more documents.

Q: Why is this project significant for the CPH?

The Transition is an important project for at least two important reasons. First, it provides a series of documents that tell the story of how a presidential administration attempted to hand off their ideas to a succeeding administration of a different political party. This sort of seemingly amicable transition is uncommon in American history, so the project provides a powerful window into understanding both the policies and the motivations of the policymakers. Second, The Transition is significant because it pulls together in one user-friendly place, a large amount of documentation that is otherwise scattered and relatively inaccessible to the average person.

The Collective Memory Project: Updates

In November, **Paul Behringer**, with his collaborators, Simon Miles and Ivan Grek, presented their work on the Collective Memory Project, "U.S.-Russian Relations under Bush and Putin," at the Association for Slavic, East European, and Eurasian Studies (ASEEES) annual conference in Chicago.



Several more interviews have been added to the project, including former Senator Joseph Lieberman, and our scholars have now interviewed 29 U.S. and Russian officials and analysts, with more in the works. So far they have published 23 interviews online. Check out the latest additions here. These original interviews highlight the pivotal role of the president in crafting foreign policy strategy and as diplomat-in-chief.

Jonathan Ng is extending the project, <u>"The United States and Latin America,"</u> begun under former postdoctoral fellow **Evan McCormick**. The interviews examine themes such as immigration, trade, post-9/11 security policy, democracy and human rights, and the legacy of the Salvadoran Civil War. The project aims to shed light on major geopolitical shifts during the Bush years — in particular, the rise of the Pink Tide and escalation of the war on drugs.
