



## Yellow Ribbon Program Application

The Yellow Ribbon GI Education Enhancement Program (Yellow Ribbon Program) is a provision of the Post-9/11 Veterans Educational Assistance Act of 2008 which allows institutions of higher learning in the United States to voluntarily enter into an agreement with VA to fund tuition expenses that exceed the tuition cap for private institutions in an academic year. Individuals receiving the Post-9/11 GI Bill® benefit at the 100% eligibility level and who have entitlement remaining are eligible for the program.
