Course Description:

This course is designed for non-business majors who have an interest in business. Accounting is a system that provides information to decision makers and as such is called "the language of business". Managers need to be able to interpret and use financial statement information in business decisions. You will learn a great deal from this class.

Course Learning Objectives and Outcomes:

To enable you to analyze financial statements, we will develop your understanding of accounting by learning the impact of business transactions on financial statements. We will learn how information is reported to the public and its use in understanding the financial position of the firm. The ultimate objective of this course is to increase your understanding of how accounting information is collected, processed, and presented to outsiders. The course should also enhance your understanding of published corporate financial statements and increase your ability to analyze a variety of financial reporting issues.

Class Format:

This class is a combination of lecture, problems solving, and class discussions. Please bring your book, spiral notebook, your binder, writing instruments, calculator (basic 4 functions) and highlighters to class. The "Class Schedule" provides a guideline for the material we will cover in this course. I list the concepts to cover in class each day, along with relevant reading from the text and recommended exercises for practice of new concepts. I do not use PowerPoint slides during class, but they will be posted for your use should you need them.

You are responsible for reading the material before each class and attempting as many of the assigned exercises and problems as you can. Without that work, the lecture will be less helpful and the problems less effective. You learn Accounting by doing the exercises and problems.

Class Expectations: The 5 P's

- 1. **Preparation.** Do the assigned readings prior to class, so that the class explanation will mean more. After class, apply your knowledge to problem solving. The more you solve, the better you learn. Preparation is success. Preparation is power.
- 2. **Presence.** If you are not present, you will not learn all the simple ways I use in class to illustrate the material. Exchange contact data with a classmate just in case to stay informed if you must miss.
- 3. **Participation.** Your learning is best facilitated by regular participation. Participation is encouraged; share your understanding with the class to advance the group's collective knowledge.
- 4. **Practice.** Do enough exercises to turn the "theoretical information" into "practical powerful skills".
- 5. Proficiency. Do and re-do homework; <u>think of "How" and "Why"</u>. Copying solutions is not the same as working the problems. Analyze and learn from mistakes. Failure at home is a great way of learning, not of leaving. "Read the English!" If you understand the problem, you will solve it correctly at home and during an exam. It is all about the techniques and strategies you learn in class. They will serve you well. To do more questions visit http://highered.mheducation.com/sites/0077862376/student_view0/index.html. Choose a chapter. Each chapter has a short multiple-choice quiz that will help your understanding. Students who are committed to the "5 Ps" generally do very well in the class.



Keys to Success:

Your success in this course is highly dependent on:

- 1) Come to class and be actively present
- 2) Doing the homework timely.
- 3) Use all resources available to you including finding a class-partner to practice and study with on a regular basis.

I suggest the following:

<u>Prior to class</u> read the pertinent chapters. Understand that accounting involves judgment, analytics, and reasoning so you will want to make sure you have read the materials before class

<u>In class</u>, ask questions and be actively involved. Be prepared when called upon, ask questions, and, even better, volunteer.

On-Time arrival to class with your Name card. I will distribute blank ones on the first day of class and it is your responsibility to bring it to every class.

<u>After class</u>, review class work immediately; review notes; go over the review problems at the end of each chapter, and complete the assigned exercises to ensure your understanding.

Copying the solutions is not the same as working the homework.

Plan to spend at least 3 hours outside of class time for each hour spent in class.

The Class TAs

The TAs are very knowledgeable and can help you a lot. They can bring value and help you succeed in this class. Do not wait until the exam is due to consult them. Last minute quick sessions do not work very well in accounting. A steady and disciplined approach is the best way. They are also available via email.

Exams and Online Quizzes:

Exams and quizzes are set forth in the assignment schedule. I expect you to take all exams/quizzes at the scheduled time with your assigned section. All exams are closed book and administered during the class period. Three hours are allowed for each exam. The exams will be in the form of both multiple-choice questions and problems exercises. This class has two (2) exams. The class schedule explicitly lists the date and time for each. If you must miss an exam for legitimate reasons, you must notify me in writing together with the supporting documentation prior to the start time of the exam. For absences that do not meet these criteria, you will receive no points for that exam and there will be no make-up dates. Taking the final exam on the university-scheduled date and time is a course requirement. Missing the final exam has severe consequences and, in most cases, results in a grade of "F".

To ensure fairness, students can only use basic four-function calculators during the exams. All devices that can store text or be programmed (e.g. cell phone, PDA, smartwatch) are prohibited. During the exam, your cell phone will be turned off and placed face up on the table in front of you. Caps with lids, such as baseball caps, must be removed or the lid turned backward. You must remove any smartwatch and place it in your bag.

Reports:

1. Summary Report # 1-- Chapter 9:

Read chapter 9 and write a summary report about your understanding of this chapter. <u>The one-page report is due May 23, 2019 on Canvas.</u>

2. Project Report # 2-- Apple:

The financial statements for this company are located on Canvas in the Files along with some guidance. Chapter 9 will also be useful to you as you write this report.

The report is due May 29, 2019 on Canvas.

The Online Quizzes:

The three (3) online quizzes will be available on Canvas at the designated time and date. The questions will be in the form of multiple-choice questions. Online quizzes will be available on Canvas. Refer to the course schedule. You may begin the online quiz at any time during the testing window. Once you begin the quiz, you must complete it in one sitting. Although there is time limit, if you lose the internet connection or your computer times out, your quiz will be submitted regardless of whether you have finished it. Plan carefully and secure a strong IT connection.
