Our clinic has the privilege of working with practicing attorneys both as counsel for other parties and as a part of our team. While this would normally be a non-issue, this father was in prison in Beaumont, TX.

Haynes and Boone reached out to its Houston office and an associate Attorney, Julian Sharp, volunteered to visit the father in prison.

A 2021 graduate from the University of Arkansas Law, Julian never expected to have this experience when he signed up for Big Law. While going to a prison is definitely daunting, he valued the experience. Julian said, "being able to help the law students and contribute to a good cause was probably my favorite aspect to it." He would recommend working with the clinic to anyone and would do it again.
