- * Scholarship applications for the Year 2012 must be postmarked by November 1, 2012
- * Awards will be from \$700 to \$1500 each, depending on the amount available, the number of applicants, their qualifications, and given at the discretion of the Adora S. Jones Ministerial Trust Administration. Awards will be made in December 2012.
