### 2024 U.S. News and World Report national universities rankings

# Road to R1: Research and Scholarly/Creative Excellence

## Dedman College of Humanities and Sciences Professor awarded \$3.5 million from the National Institutes of Health (NIH)

Dedman College of Humanities and Sciences' Department of Chemistry Professor John Buynak and his team have received a \$3.5 million, 5-year grant from the <u>National Institutes</u> of <u>Health</u> to design and synthesize new antibiotics to fight some of the deadliest and most

clinically-challenging infections of the 21st century – drug-resistant strains of bacteria that cause tuberculosis and leprosy.

These new antibiotics called 'atypically substituted' drugs, are a modified version of a class of antibiotics known as carbapenem antibiotics, which weaken the cell wall of mycobacterial strains, causing bacteria to burst and die. <a href="Professor Buynak's research">Professor Buynak's research</a> has shown that these modified drugs are more effective at killing mycobacterial strains and less likely to negatively affect normal bacteria and cause unnecessary side effects when compared to current carbapenems.

## The Deason Criminal Justice Reform Center awarded grant from the U.S. Department of Justice

SMU's <u>Deason Criminal Justice Reform Center</u> has received a grant from the U.S. Department of Justice's (DOJ) <u>National Institute of Justice's Research and Evaluation on the Administration of Justice: Advancing Access to Justice 60 Years after Gideon Program for \$800,000. The center will utilize these funds to continue work on their project, *Building Better Indigent Defense Systems*, which looks to answer the question "do more structured defense delivery systems—such as staffed public defender offices and managed assigned counsel programs — do a better job at providing eligible people with appointed counsel?" Employing the center's research-for-reform model, this study will generate actionable recommendations for policymakers and indigent defense leaders.</u>

Congratulations to Andrew L. B. Davies, Director of Research at the Deason Criminal Justice Reform Center, on achieving this milestone.

October 11, 2023. Two proposals will be selected to receive grant funding – travel grants may be awarded up to \$10,000 and research grants may be awarded up to \$15,000.
