Financial aid and scholarships at SMU

SMU is ready to connect you with the right financial resources to support your educational goals. We consider your family's unique financial circumstances for need-based aid and partner with you to explore federal, state and SMU-funded awards.

ACADEMIC AND MERIT-BASED SCHOLARSHIPS

When you apply to SMU, you are automatically considered for a range of SMU scholarships. Many of these programs not only offer financial assistance but also provide students with unique academic opportunities that encourage curiosity and community.

School-Specific Scholarships

Awarded to selected students who express an academic interest in any of our five undergraduate schools.

NEED-BASED ASSISTANCE

We have several need-based programs available to help meet your educational expenses. These include SMU-funded financial aid offers as well as state and federal sources of financial assistance, depending on financial need and residency.

HOW TO APPLY

Submit these forms by your chosen application deadline: **November 1** for Early Decision I and Early Action or **January 15** for Early Decision II and Regular Decision.

#1 – Free Application for Federal Student Aid (FAFSA)*

U.S. and eligible noncitizens seeking eligibility for federal and state sources of aid must submit the FAFSA each year. **studentaid.gov.** SMU school code 003613.

*Texas Application for State Financial Aid (TASFA)

Students who classify as Texas residents but are not eligible to submit the FAFSA are encouraged to complete the TASFA each year. www.mytexasfuture.org. Submit your completed TASFA application to fa.verification@mail.smu.edu.

#2 – The CSS Profile[™]

For SMU-funded institutional offers, submit a CSS PROFILE™ application each year. cssprofile.collegeboard.org. SMU school code 6660.

Our financial aid staff will use the FAFSA or TASFA and the CSS Profile™ to provide a financial aid offer which includes a variety of federal, state and SMU-funded financial offers.

HOW DO I APPLY FOR ACADEMIC SCHOLARSHIPS?

When you submit your application for admission by January 15, you are automatically considered for SMU's generous scholarships. To be considered for the President's Scholarship (smu.edu/ps), you must submit an additional essay. To be considered for the Hunt Leadership Scholarship (smu.edu/hunt), you must submit an additional essay and a YouTube video statement.

WHAT KIND OF FINANCIAL AID IS AVAILABLE?

Scholarships, grants and self-help aid such as loans and work-study opportunities.

WHO IS ELIGIBLE FOR ACADEMIC SCHOLARSHIPS AND FINANCIAL AID?

All applicants are considered for academic scholarships. U.S. and eligible noncitizens who submit the Free Application for Federal Student Aid (FAFSA) or the Texas Application for State Financial Aid (TASFA), along with the CSS Profile™, are considered for need-based and self-help financial aid.

WHAT DOES IT COST TO ATTEND SMU?

Regardless of a student's state of residency or citizenship, tuition and fees for the current 2025–2026 academic year are \$69,722; the estimated average housing and meal plans are \$19,794.

WHEN DO I APPLY FOR FINANCIAL AID?

The priority deadline to apply for institutional aid corresponds with your chosen application deadline. To be considered for SMU-funded need-based aid, file the CSS Profile™. To be considered for federal need-based aid, submit the FAFSA form.

HOW DOES SMU DETERMINE THE AMOUNT OF FINANCIAL ASSISTANCE?

SMU receives information from your FAFSA or TASFA, along with the CSS Profile™, and compares the cost of attending SMU with the Student Aid Index (SAI) to determine your financial aid package.

WHEN WILL I RECEIVE MY AWARD NOTIFICATION?

Students who have completed their aid application (including FAFSA and CSS profile) should receive notification within a month.

WHAT IF I RECEIVE AN OFF-CAMPUS SCHOLARSHIP?

You should notify Student Financial Services of any expected scholarships from outside sources.

HOW DO I ACCEPT MY FINANCIAL AID AWARDS?

Pay your enrollment deposit, then go to your my.SMU portal to accept or decline any specific awards. If you have questions, please contact Student Financial Services.
