Methods of Payment

SMU provides various payment options for students and their families, including checks, money orders, credit cards (American Express, Discover, MasterCard, VISA), wire transfers, and financial aid. They also offer extended payment plans to help manage expenses. Additionally, the University administers payment plans through the Division of Enrollment Services, in partnership with state and federal financial aid sources.

SMUPAY

SMU provides a secure website through which you can make electronic check (eCheck) and electronic credit card (American Express, Discover, MasterCard and VISA) payments to your SMU accounts. Payments made online will be posted to the student and/or miscellaneous account at once. At the time of electronic payment, a receipt will be provided. Please visit SMUpay, which is located on the left-hand side of your my.SMU Student Dashboard.

Note: Credit card (American Express, Discover, MasterCard, and VISA) payments will be processed through Flywire. If you choose this option, a non-refundable service charge fee will be added for each transaction. The non-refundable service charge fee is 2.85 percent for US based credit/debit card payments and 3.95 percent service fee per transaction for international non-US card payments.

Make sure the pop-up blocker is off. SMUpay requires Microsoft Internet Explorer 8 or newer, Mozilla Firefox 17 or newer or Google Chrome 24 or newer with JavaScript, Cookies and Secure Sockets Layer (SSL) enabled.

CREDIT CARD PAYMENTS

Credit card (American Express, Discover, MasterCard, and VISA) payments will be processed through Flywire. If you choose this option, a non-refundable service charge fee will be added for each transaction. The non-refundable service charge fee is 2.85% for US based credit/debit card payments and 3.95% service fee for international non-US card payments per transaction.

eCheck (Personal Checking or Savings) PAYMENTS

(no service charge fee)

You will need to provide your bank account's routing number and checking or savings account number. If you have questions about the correct numbers to use, please contact your financial institution. Keep in mind that some banks use different routing numbers for ACH transactions and wire transfers. The routing number you need to use for payment through an eCheck is the ACH routing number, which is typically found at the bottom of your check and is the left-most number, followed by your account number, and then by the number of the check. Do NOT use any numbers on your debit card.

Requirements for non-checking accounts: For savings account routing numbers, contact your financial institution. Deposit slips may not include the correct routing number. Not all payments from brokerage/investment accounts can be made online; please check with your account representative. Checks written from credit card accounts, commonly called convenience or credit advance checks, may not allow electronic transactions. Contact your financial institution to find out if ACH transactions are allowed.

STUDENTS

Begin processing by logging on to <https://my.SMU.edu>. Select Students tile, click on Student Dashboard, click on Financials on the left-hand side menu, click on SMUpay.

FACULTY/STAFF

Begin processing by logging on to <https://my.SMU.edu>. Select Employees tile, select Employee Self-Service on the drop-down menu, click on the Financial Account tile, select a term, and click on an amount, click on SMUpay.

AUTHORIZED PAYER (SMUPAY: VIEW BILLS AND MAKE PAYMENTS)

Students can add Authorized Payers on their SMUpay account. Authorized Payers can view a student's bills, statements and unbilled activity, as well as make payments. When students add an Authorized Payer, the added payer will receive an email that will have the User ID and URL needed to complete the Authorized Payer setup. Parents and others can access a student's account once they have been added as an Authorized Payer. Students should visit smu.edu/bursar/smupay.asp page for further instructions on adding an Authorized Payer. Instructions for resetting a login name and password can also be found on this website.

DOMESTIC AND INTERNATIONAL WIRE PAYMENTS

SMU has partnered with Flywire to provide our international students with easy and secure methods to send international payments through your my.SMU portal or Authorized Payer account.

Make Payment to the student account by selecting the Link in SMUpay and completing the process. Save on bank fees and exchange rates. You can make international wire payments to the student account by selecting the link in SMUpay and completing the process. Provide the correct Student SMU ID number for payment to be applied correctly. Be sure to follow the selected wire vendor's instructions to complete payment through your bank. The payment will be posted to your student account within 24 hours of the payment status being delivered to Flywire. Payments must be paid far enough in advance to be posted to your account by the due date.

529 COLLEGE SAVINGS PLAN AND STATE PREPAID COLLEGE PLANS

Many financial institutions offer college savings programs that enable families to save money for a child's college education. Each financial institution has separate rules and regulations that govern how funds may be used and how they are sent to SMU. Please check with your financial institution to see if a digital distribution option is available through Flywire.

FACTS ABOUT MEAL PLANS

- All resident students must have a meal plan. First-year and second-year residential students are required to have one of The Works meal plans. After completing the first two years, a resident student may select from The Works meal plans or Block 150 options.
- Resident students who are senior- or graduate-level may select the Senior Block 50 or any of the above listed meal plans.
- Each meal plan listed above is available to nonresident students.
- Meal plans may be used in Umphrey Lee Center, Arnold Dining Commons or in McElvaney Commons (Mac's Place) by using meal swipes.

- The Works and Block 150 meal plan both have 10 Guest Passes, per semester, which can be used for any guest, provided members are present at the time of transaction. Guests of members on a Block 50 meal plan are admitted by paying the door entry rate per guest from the member's Flex Dollars account.
- Flex Dollars are a stored-value, declining-balance program that works on the same principles as a debit card.
- Flex Dollars may be used to buy meals or commodities at any SMU Dining Services location on campus.
- Flex Dollar balances carry over from summer to fall to spring terms, expiring at the end of each academic year.
- Door rates for dining without a meal plan at the dining halls are: \$10.84 (plus tax) for breakfast, \$13.23 (plus tax) for lunch and \$15.41 (plus tax) for dinner. Rates for continuous service periods between standard meal periods are calculated at the prior meal-period rate.
- A meal plan may be changed through the last day of add/drop, allowing one change per term for all plans. Unless a different meal plan is selected, students will be enrolled automatically in the spring for the same meal plan selected for the fall term.

Dr. Bob Smith Health Center

The mission of the Dr. Bob Smith Health Center is to provide quality, caring, cost-effective and convenient ambulatory healthcare services. Students also have access to healthcare education services that promote healthy lifestyles and enhance academic productivity. The healthcare services and university-wide education initiatives help students achieve a satisfying and rewarding college experience.

Beginning in fall 2013, a new fee for health services was charged to the student tuition account. The fee is mandatory for all undergraduate and graduate students enrolled at the Dallas and Plano campuses and is separate from any mandatory insurance costs.

For each term (fall and spring) the fee is:

- \$140 per term for full-time (12 or more credit hours) undergraduates (not living in a residence hall)
- \$80 per term for part-time (1 to 11 credit hours) undergraduates (not living in a residence hall)
- \$140 for all graduate students (not living in a residence hall)
- no charge for Study Abroad
- no charge for Taos

Summer the fee is \$60.

This fee is assessed only to students who do not live in a residence hall. Otherwise, this fee is incorporated in the student's rent.

The fee allows the University to enhance healthcare facilities and services for students, including increased access to specialists and mental health counselors. Note that students must also maintain health insurance to cover the costs of specialty care, prescriptions, emergency care, inpatient care, and other off-campus health services. This requirement can be met either by buying the Student Health Insurance Plan (SHIP) or an alternative insurance plan that has comparable benefits.

All SMU students paying tuition and fees, including the Health Center Fee, are eligible for the following services at no additional cost. These services are independent from those covered by SHIP or a student's private health insurance. Students who are in programs that do not charge fees, including the General Student Fee and the Health Center Fee, can pay at time of service.

Primary care medical services at the Health Center at no added cost, including:

- Medical appointments during weekday hours
- Access to a convenient pharmacy on premises
- Influenza vaccinations

Counseling and Psychological Services (CAPS), including:

- Psychological evaluation and short-term therapy
- Initial psychiatric medication evaluation
- 24-hour crisis on-call services

Health Education programs, including:

- Alcohol and other drug evaluation and education
- Nutrition counseling and education
- Sexual health and relationships consultation and education

Mandatory Health Insurance

SMU is committed to the health and well-being of all students. The Student Health Center is here to serve and provide students with medical care while attending the University. To ensure that students have proper healthcare coverage, a mandatory health insurance requirement was passed by the President's Executive Council in February 2008. This mandatory health insurance policy requires domestic students, both undergraduate and graduate, enrolled in nine or more credit hours to keep insurance coverage as a condition of enrollment. All international students enrolled in one or more credit hours must enroll in the Student Health Insurance Plan (SHIP), unless they receive a special waiver personally granted by the SMU Insurance Department. Optional Dental Insurance enrollment will be available via online enrollment through Academic Health Plans website at <http://smu.myahpcare.com>.

Financial Policies

Students are individually responsible for their financial obligations to the University. Tuition is charged based on each student's credit hour enrollment and primary academic career.

Students with overdue accounts or other unpaid financial obligations may be denied services from the Office of the University Registrar, including diploma issuance and readmission, until all debts are resolved. The Division of Enrollment Services and Student Financial Services may block or cancel registration for students with delinquent accounts. The University may also assess attorney's fees and collection costs (up to 50% of the outstanding balance). By enrolling, students agree to abide by all University rules, regulations, and policies.

Once outstanding debts are paid, students must obtain clearance from the Division of Enrollment Services and Student Financial Services before registering or receiving their diploma.

Financial aid applications should be submitted well before registration, following the deadlines set by the Division of Enrollment Services, Student Financial Services. Late applications may experience processing delays, which can postpone financial aid disbursement. Regardless of aid status, students and families must pay all charges by the published due dates. Any aid disbursed after the payment deadline will first be applied to outstanding charges.

Payment Policies and Procedures

All tuition, fees, housing, food plan, and other University charges are paid online through the SMUpay option at my.SMU.edu. Students and Authorized Payers may choose from the following payment methods:

- **Electronic check (eCheck):** No service charge.
- **Credit Card:** 2.85% non refundable service charge for US based credit/debit card payments - AMEX, Discover, MasterCard, VISA and 3.95% non refundable service charge for international non-US card payments.
- **Wire Transfer:** Flywire for international wires (service fees may apply).

Returned check payments or credit card chargebacks are considered nonpayments. These must be replaced with a cashier's check or money order. Nonpayment may result in withdrawal from the University and require that all future payments be made via cashier's check or money order. A \$30 fee is assessed for each returned payment.

Payment in full must be posted to the Student Account by **11:59 p.m. CT** on the payment due date listed on the student's bill. Initial term payment due dates are available on the Student Financial Services website.

Billing notifications are sent to the student's SMU e-mail and to any Authorized Payer's provided e-mail when a bill is generated. The e-mail includes instructions for accessing the bill online via SMUpay. If no notification is received two weeks prior to the due date, students or Authorized Payers should contact Student Financial Services

Payment deadlines:

- **In-person or mailed payments** must be received by 4:00 p.m. CT on the due date.
- **Online payments** must be posted by 11:59 p.m. CT on the due date.

Online payers automatically receive an electronic payment confirmation. Others can verify payment receipt through SMUpay. Students enrolling after the payment due date must pay at the time of enrollment.

If utilizing federal or state loans for payment, funds must be posted to the Student Account by the payment due date.

Schedule Changes

Students who drop courses during the scheduled add/drop period, but still remain enrolled in other courses, will not be charged tuition or fees for the dropped courses. (Undergraduate students are charged a flat tuition rate for 12-18 credit hours). No tuition reduction is provided for any courses dropped after the add/drop period ends.

A student who drops all courses will either be canceled or withdrawn, depending on the date of the transaction.

Effective Fall 2017, all academic careers have an extended deadline to drop a course or withdraw from the University without an academic record. This deadline is the 10th class day of the term and applies to the fall and spring terms only. (See the Academic Calendar for specific dates.)

Important: Tuition is not reduce for any courses dropped after the official add/drop period. If a student drops all courses by the extended deadline, they will be canceled from all courses, but the Withdrawal Refund Schedule will apply.

Past Due Payment Fee

After the monthly payment due date has passed, a 1.5% past due fee will be assessed on the unpaid student and/or miscellaneous account each month until the balance is paid. The enrollment of students whose accounts are unpaid after the payment due date may be canceled at the university's discretion.

SMU Bookstore Direct Charge Policy

SMU allows students to have purchases from the SMU Bookstore charged directly to their miscellaneous student account. Charges are billed monthly and are due on the date specified on the bill. Students with outstanding balances on their miscellaneous account will be charged 1.5% monthly on the past due balance. Students who have an outstanding balance during their tenure at SMU may lose the privilege to use direct charge from the SMU Bookstore. Students with repeated delinquencies on the account and/or returned checks will lose the privilege for the rest of their matriculation at SMU.

Student Refunds

Student loan funds, that create a credit on the student's account, received by SMU before the first day of class will be processed for refunding once the funds are posted to the Student Account. Per regulations for federal aid:

- Refunds may be processed no earlier than 10 calendar days before the first day of class, if funds are disbursed to the account.
- Refunds must be issued within 14 calendar days after the first day of class.
- For loans funds disbursed after the first day of class, allow up to 14 calendar days from the date of the posting for the refund to be processed.

Any outstanding debts to the university that include Title IV funds (federal financial aid) must have the appropriate form(s) on file in order to transfer funds to cover current aid year debts:

- **Authorization to Credit Account form (ACA)** - Completed by student
- **Authorization to Credit Account Parent form (ACAP)** - Completed by parent Plus loan borrower.

Any outstanding university debts that do not include Title IV funds will be deducted from the credit balance before issuing the refund.

SMU has partnered with Heartland ECSI Refund Select to issue refunds. To enroll in direct deposit:

1. Log into my.SMU.edu
2. Select the "Financial Account" tile.
3. Click on the MyRefundSMU link on the left-hand menu.
4. Create a profile (username must begin with a letter and cannot have spaces or special characters).
5. Select "Direct Deposit" as your preferred method for refunds.

Note: You must be eligible to enroll to access RefundSelect.

Refunds are processed continuously throughout the year as financial aid is applied. To check on the status of a refund, students may contact Student Financial Services 14 calendar days after aid has disbursed to the Student Account.

Housing and Food Plan

The Housing Agreement is made for fall and spring terms or for one or both five-week summer sessions. Should a student move from the residence hall at any time, the rest of the rent for the term(s) or five-week summer session(s) will be due. For more specific information, read the Housing Agreement form or consult with the Department of Residence Life and Student Housing. A percentage of food plan charges may be refunded based on the date of official withdrawal from the University.

TUITION AND FEES SCHEDULE FOR CANCELLATION/WITHDRAWAL

A student who officially cancels his or her enrollment or withdraws from the University is charged only a portion of their tuition and fees based on the effective date of the cancellation or withdrawal.

FEDERAL AID POLICY ON FULL CANCELLATION OF CLASSES AND TOTAL WITHDRAWAL FROM THE UNIVERSITY

Return of Federal Student Aid Funds

The Higher Education Amendments of 1998 establishes the principle of "earned aid/unearned aid" for administration of federal student aid. A student "earns" federal aid in proportion to the percentage of the term completed. Students withdrawing from the University before completing 60% of the term will be subject to the Federal Return to Title IV (R2T4) calculation. The R2T4 calculation is used to determine the amount of aid a student has earned during a term. Any student that completes 60% of a term is considered to have earned 100% of their financial aid funds for that term. Students who do not complete at least 60% of the term may be required to return the "unearned" portion previously disbursed financial aid. For example, a student who completes 30% of the term has "earned" 30% of their federal aid eligibility for that term; however, SMU and/or the student may have to return the "unearned" 70% of aid. Students who complete 60% of a term are considered to have earned 100% of their aid for that term.

A student who receives a refund of financial aid funds for educational expenses that are not billed directly (books and supplies, transportation, living and/or personal expenses) may be required to return the unearned portion of that refund. Federal regulations require all schools to notify the U.S. Department of Education of any student who is required to return an unearned portion of financial aid funds received. The student is ineligible for additional federal aid, at any institution, until repayment is made in full.

STUDENT FINANCIAL SERVICES POLICY ON TUITION REVERSAL FOR A FULL CANCELLATION OF CLASSES AND TOTAL WITHDRAWAL FROM THE UNIVERSITY

Per Federal Regulation, a credit balance resulting from a withdrawal calculation **MUST** be returned to the Federal Financial Aid programs first. Once all required reductions in financial aid programs have been completed, any remaining funds will be refunded to the student.

Attribution of Refunds to Aid Programs

- Unearned funds must be returned to the funding source(s) in accordance with federal, state, and institutional policies.

- Federal aid programs must be returned in the following priority sequence: Federal Direct Unsubsidized Loans, Federal Direct Subsidized Loans, Federal Direct PLUS Loan, Federal Pell Grant and Federal SEOG.
- Any portion of the unearned financial aid not attributed to federal Title IV programs will be returned to non-federal funding sources in the following priority sequence: state grant, SMU gift aid, private gift aid, private loan, and student/parent.
- In no case will funds returned to a source exceed the disbursement for that payment period made from the source.

Payment Options

SMU offers a variety of payment options and plans to aid its students while they are in college. These payment options include cash, check, eCheck*, money order, cashier's check, electronic credit card (American Express, Discover, MasterCard, and VISA), direct wiring of funds and financial aid. In addition to the above payment options, SMU provides payment plans to aid in college expenses administered by the Division of Enrollment Services. SMU MONTHLY PAYMENT PLANS

Objective: Pay term charges for tuition, fees, room, and meal plan in monthly installments with no interest charges.

Payment Plan Options: The SMU monthly payment plans are available on a term basis. Payment plans **do not** automatically renew. For each term you wish to make monthly payments, you must enroll in a new payment plan. Payment plans are available for Fall, Spring and Summer Terms. Plans are not available for Jan, May, August, and Winter Terms. An open balance from a previous term cannot be added to a current payment plan and payment plans cannot be applied to Miscellaneous account charges.

Term Payment Plans include:

- **5-Month Payment Plan:** The 5-Month Payment Plan runs August 20 through December 20 for fall and January 20 through May 20 for spring, with a \$70 per term nonrefundable enrollment fee and an enrollment deadline of September 30 for fall and February 28 for spring.

Term Payment Plans include:

- **Summer Tuition Payment Plan:** The Summer Payment Plan consists of 3 installments: May 20, June 20, and July 20, with a \$75 nonrefundable enrollment fee and an enrollment deadline of June 10. Please note that this plan may overlap with the fall and spring plans, so please plan accordingly should you decide to enroll.

Enrollment

A student or an "Authorized Payer" can enroll in one payment plan per term. Multiple payment plans per term are not allowed. The student or Authorized Payer who creates the payment plan will become the "Plan Owner". Changes to the payment plan can be made by the student, Authorized Payer, SMU, and Flywire. Only the Plan Owner can change the payment method (current bank account or credit card used for scheduled payment plan payments).

Automatic payment is required to enroll into a payment plan. Payments must be made via automatic deduction (ACH) from a regular United States checking or savings account or via credit/debit card (American Express, Discover, MasterCard, and VISA). ACH payments are free of charge. US based credit/debit card payments will be assessed a non-refundable 2.85 percent service fee per transaction and international non-US card payments will be assessed a non-refundable service fee of 3.95 percent service fee per transaction (charged by our payment processor, not SMU). ACH payments are processed on the 5th or 20th of the month, depending on which payment plan you select. When the 5th or 20th falls on a weekend or holiday, ACH payments are processed the following business day. Dates and plan terms may be subject to change without notice.

Additional Information

Please consider one of these payment plans or make full payment directly to SMU by the payment due date in order to avoid a past due fee. Charges exceeding your financial aid should be resolved by paying in full or by enrolling in a plan by the due date. A down payment will be required if you enroll in a payment plan close to or after the first installment is due. SMU PREPAYMENT PLAN (One Single Payment Up Front for All Terms)

SMU allows a matriculated undergraduate full-time (12 - 18 credit hours) student to prepay a minimum of two years and up to four years of tuition and general student fees at the current year rate. It covers fall and spring terms only.

The prepayment amount is due on the payment due date for the fall term; or, if the current fall term has already been paid in full by the payment due date, the remaining terms must be fully paid by the last day of October of the current school year.

Scholarships and grants may not be used to reduce the prepayment amount.

If the student withdraws or is dismissed from SMU, the unused credit in the prepayment account will be refunded to the signatory on the enrollment form, after the student's account has been paid in full.

TAX EXCLUSION

Gift Tax Exclusion

Under the Internal Revenue Code, Section 2503(e)(2)(A), a direct transfer of funds to an educational institution such as SMU to be applied to cover the present and/or future costs of tuition for a college or university student does not count as a "gift" for federal gift tax purposes. Estimated Expenses - Cost of Attendance

Cost of Attendance Information

The purpose of the **Cost of Attendance (COA)**, sometimes referred to as the "student budget", is to provide an estimated cost to attend SMU for a single academic year consisting of two terms (fall and spring) or nine calendar months (September to the following May). The COA is updated annually. The following information should be used as a guide when planning educational finances for the academic year.

The COA not only helps students with understanding some of the potential costs associated with attending college, but it is also used to determine a student's maximum eligibility for most types of financial aid including federal, state, and institutional need-based aid, scholarships, as well as loan eligibility. It is important to understand that the Cost of Attendance, as it relates to your financial aid, is the estimated cost for most students in a specific degree program and includes an allowance for housing, meal plan, transportation, books, supplies, and miscellaneous expenses as well. It is NOT the actual amount that will be owed to the University.

Direct Costs vs. In-Direct Costs:

- **Direct costs** are those billed directly by the university such as tuition and fees, along with housing and meal plan for students who are living on campus.
- **In-Direct costs** are educationally related expenses not billed by the university. For example, students who live off campus are expected to pay rent and utilities such as electric, water, and internet service. These are all expenses related to their education but may not be billed directly by SMU. They are "in-direct costs". These expenses may vary significantly depending on a student's choice in housing, neighborhood, utility, service plans, etc.

Again, the information below is estimated. Amounts may vary depending on the individual student's degree plan, number of hours enrolled, choice of housing, and specific program of study. It should only serve as a point of reference for students and their families to decide how much it may cost to attend SMU. It is NOT the amount you will be required to pay.

Each of these should be considered when evaluating your housing options.*

Loans

SMU and other investment partners offer your family several loan options featuring low-interest rates and extended repayment options. Some loans are awarded based on documented financial need, others on creditworthiness and income. All loans must be repaid; they are not considered gift aid.

FEDERAL DIRECT SUBSIDIZED LOAN

- **Funding Partner:** U.S Federal Government
- **Eligibility:** Awarded based on financial need shown by the Free Application for Federal Student Aid (FAFSA).
- **Amount:** Up to \$3,500 for the first year; \$4,500 for the second; \$5,500 for subsequent junior and senior years.
- **Interest Rate:** Fixed 6.39% for Undergraduate loans disbursed on or after July 1, 2025, and before July 1, 2026. Interest accruals are subsidized by the Federal government until the loan enters repayment.
- **Repayment:** Begins six months after student ceases attending at least half-time (6 credit hours). Interest begins accruing the month after graduation.

FEDERAL DIRECT UNSUBSIDIZED LOAN

- Similar to the Federal Direct Subsidized Loan, with two exceptions: Demonstrated financial need (as determined by the FAFSA) is not required, and interest accruals, which begin at the point of disbursement, are the responsibility of the student borrower. Undergraduate students may borrow \$2,000 annually, at an interest rate of 6.39% annually. Graduate students may borrow \$20,500 annually, at an interest rate of 7.94% for loans first disbursed on or after July 1, 2025, and before July 1, 2026.

FEDERAL DIRECT PARENT PLUS LOAN

- **Funding Partner:** U.S. Federal Government
- **Eligibility:** Parent is borrower with a credit review; FAFSA record on file with the school.
- **Amount:** Cost of attendance minus other financial aid.
- **Interest Rate:** Fixed 8.94% for loans first disbursed on or after July 1, 2025, and before July 1, 2026.
- **Repayment:** Begins immediately after final disbursement of the loan for the year, unless a payment deferment request is completed. Repayment can be deferred up to six months after student's graduation or student falls below half-time enrollment status (6 credit hours).

FEDERAL DIRECT GRAD PLUS LOAN

- **Funding Partner:** U.S Federal Government
- **Eligibility:** Borrower (student) creditworthiness, FAFSA record on file with the school.
- **Amount:** Cost of attendance minus other financial aid.
- **Interest Rate:** Fixed 8.94% for loans first disbursed on or after July 1, 2025, and before July 1, 2026.
- **Repayment:** Begins immediately but can be deferred with a minimum of half-time enrollment (6 credit hours).

COLLEGE ACCESS LOAN (www.hhloans.com)

- **Funding Partner:** Texas Higher Education Coordinating Board.
- **Eligibility:** Verified Texas resident; creditworthy co-signer needed.
- **Amount:** Up to cost of attendance minus any other financial aid.
- **Interest Rate:** Fixed 6.30% for loans certified on or after July 1, 2025. Interest is not capitalized.
- **Repayment:** Loans have a six-month grace period from the date a borrower ceases to be continuously enrolled as at least a half-time student at an eligible institution. Principal balances

under \$30,000 have up to a ten-year repayment period with minimum monthly payments of \$50. Principal balances of \$30,000 or more have a repayment period up to 20 years.

- Postponements of loan repayment and income-sensitive or graduated repayment schedules are available.

Guidelines for Need-Based Assistance

SMU follows the philosophy that financing a college education is a shared investment among the government, the University and families. We believe students and their families have the primary responsibility to contribute to educational expenses to the extent they are reasonably able. Eligibility for need-based financial aid is determined according to the specific criteria required by each funding source.

SMU FUNDED NEED-BASED AID

SMU considers an undergraduate student to be dependent upon their families. To be considered for SMU need-based funds, each student must submit the Free Application for Federal Student Aid (FAFSA) and the College Board's CSS/PROFILE® application each academic year.

Per federal regulations, a student is classified as "dependent" unless they satisfy one or more of the following requirements. If the answer is yes to any of the following, the student is classified as "independent."

- The student is an orphan or a ward of the court.
- The student is a U.S. military veteran.
- The student provides more than half of the financial support for a dependent other than a spouse.
- The student is married.
- The student turns 24 years of age before December 31 of the academic year for which aid is sought.
- The student was in foster care after age 13.
- The student was an emancipated minor by the court in the student's state of legal residence.
- The student was under legal guardianship as determined by a court in the student's state of legal residence.

The university reserves the right to alter the combination of gift aid and self-help funding (student loan and work programs) from year to year based on a family's demonstrated financial need as determined through the FAFSA and CSS/PROFILE® applications, along with the availability of funds, current university policies approved by the SMU Board of Trustees, and federal/state legislation. As students advance toward degree completion, the proportion of self-help aid in their financial aid offer generally increases..

STATE AND FEDERAL ELIGIBILITY GUIDELINES

To be eligible for federal and/or state financial aid, a student must meet the following criteria:

- Be in good standing with the university.
- Meet or exceed the minimum standard for Satisfactory Academic Progress (SAP) in an approved, degree seeking or certificate program.
- Not be in default on any federal or state student loan or have borrowed more than the loan limits
- Not be flagged for a previous federal or state grant overpayment
- Be a U.S. citizen or an eligible non-citizen for federal aid programs
- Be a Texas resident as defined by State of Texas for state aid programs

FEDERAL VERIFICATION REQUIREMENTS

Students may be selected for verification by SMU (Institutional selection) or by the U.S. Department of Education (Federal selection). If selected, students and their families must submit any and all documents requested by the university to confirm and verify the accuracy of data submitted on the FAFSA. Supporting documentation may include, but is not limited to, signed copies of 1040 income tax returns, official tax transcripts from the U.S. Internal Revenue Service, W-2's, household size documentation, legal marriage and/or divorce documentation including child custody and support decrees, and non-custodial parent financial information. All required documentation should be submitted within the time limit provided at the time of notification. Financial aid offers and aid funds may not be awarded or disbursed until the verification process is complete.

Grants

GRANTS AND NEED-BASED AWARDS (GIFT-AID)

Grants are primarily awarded based on demonstrated financial need. Amounts may vary each year, depending upon the information provided on the Free Application for Federal Student Aid (FAFSA) and CSS/PROFILE® applications. Both the FAFSA and CSS/PROFILE® must be submitted each academic year for continued consideration.

FEDERAL PELL GRANT

- **Awards:** Amounts vary based on number of enrollment hours.
- **Funding Source:** Federal government.
- **Eligibility:** Determined by the U.S. Department of Education based on analysis of a student's completed FAFSA; awarded to students with high financial need.

FEDERAL SUPPLEMENTAL EDUCATIONAL OPPORTUNITY GRANT (SEOG)

- **Awards:** Up to \$4,000; vary in number depending on allocation to SMU. Funds are extremely limited.
- **Funding Source:** Federal government.
- **Eligibility:** Priority given to Pell Grant recipients; awarded as part of the financial aid offer to those who meet federal and SMU criteria.

TEXAS TUITION EQUALIZATION GRANT (TEG)

- **Awards:** An award amount may vary depending on allocation to SMU and date of application. The standard amount is \$4,270. Students who meet the state guidelines for exceptional financial need may receive up to a maximum of \$6,405 if funds are available.
- **Funding Source:** State of Texas.
- **Eligibility:** Must demonstrate financial need and meet the Texas State Residency requirements as defined by the Texas Higher Education Coordinating Board. Must maintain an enrollment status of three-quarter time. Awards are based on the availability of funds as determined by the Coordinating Board.
- **Renewal Requirements:** Must maintain Satisfactory Academic Progress (SAP) as defined by SMU, must successfully complete a minimum of 24 credit hours per academic year, must successfully complete at least 75 percent of hours attempted, and maintain a cumulative GPA of 2.500 or higher.

SMU OPPORTUNITY AWARD

- **Awards:** Vary annually based on a family's finances as demonstrated by the CSS/PROFILE®.
- **Funding Source:** SMU.
- **Eligibility:** Awarded based on financial need demonstrated by the CSS/PROFILE® as part of the financial aid offer after self-help and other gift aid is provided.

Employment

National studies show that students who work part-time during college often benefit both financially and personally. Part-time employment helps students supplement their income while developing valuable skills such as time management. According to a U.S. Department of Education survey, students who work part-time also have significantly higher retention rates compared to those who do not work. Earnings from the following student employment programs are paid directly to the student on a bi-weekly basis and are not applied toward University billing charges. For information on current job openings, visit the Financial Aid Student Employment Office website at smu.edu/enrollmentservices/financialaid/typesofaid/studentemployment.

FEDERAL WORK-STUDY PROGRAM

The Federal Work-Study (FWS) program offers on- and off-campus community service along with on-campus work opportunities to eligible students.

- **Funding Source:** Federal funds matched by SMU.
- **Eligibility:** Must file a Free Application for Federal Student Aid (FAFSA) as part of the application process for FWS aid, awarded as a part of a need-based financial aid package.

ON-CAMPUS STUDENT EMPLOYMENT

On-campus employment is available to students based solely on the desire to work on campus.

- **Eligibility:** SMU students.

Academic Scholarships for International Students

SMU offers a limited number of undergraduate academic scholarships to students who are citizens of foreign countries and exhibit an outstanding academic record.

In the Department of Homeland Security (DHS) regulations, international students are allowed to work only on campus while attending school in the United States. Students must be enrolled as full-time students and can work a maximum of 20 hours per week. Between periods of enrollment (summer, winter, etc.), a student may work 40 hours per week. Inquiries concerning financial assistance for graduate study should be sent to the graduate division of the SMU school in which the student hopes to enroll.

SMU Satisfactory Progress Policy

SMU SATISFACTORY ACADEMIC PROGRESS (SAP) POLICY (Federal, State and Institutional Financial Aid)

Federal regulations require students to meet specific Satisfactory Academic Progress (SAP) requirements to maintain eligibility for financial aid. Students are evaluated at the end of the spring term, prior to the start of the summer term, to verify academic progression. The following information describes various measurements used to determine satisfactory academic progress and the minimum SAP requirements to keep eligibility for federal, state, and institutional financial aid programs.

****NOTE**** Most SMU merit-based scholarships require a minimum GPA of 3.000 or higher. For more information on the retention requirements for your specific academic scholarship, please refer to your academic adviser or academic catalog.

Standards of Measurement:

Cumulative GPA (Qualitative Measurement)

All careers & academic programs are measured at the end of the spring term each year (unless otherwise noted). Measurement is based on the following.

- **Undergraduate Students** – Minimum cumulative GPA of 2.000 or higher.
- **Graduate Students** – Minimum cumulative GPA of 2.000 for all programs unless otherwise required by the academic department or graduate program of study. Academic departments may require a minimum cumulative GPA greater than 2.000 for all students enrolled in a specific program of study. The GPA used to determine SAP for any specific program will be stated in each school's academic catalog. If there is no GPA requirement listed for the school or program, a GPA of 2.000 will be used.

Degree Completion Rate (Quantitative Measurement)

Schools must ensure that students are progressing toward completing their degree at a reasonable rate. The rate of completion is measured as follows:

Completion rate = Total number of earned hours ÷ Total number of hours attempted.

- **Undergraduate** - Required completion rate of 75%.
- **Graduate** - Required completion rate of 67%.

Program/Time Limits

- **150% Hour Limit** – The total number of hours attempted by students, both undergraduate and graduate, cannot exceed 150% of the total number of hours required to earn the degree. Students exceeding 150% are not eligible to receive federal, state, and institutional aid.
 - **Changing Majors** – A student who has attempted 150% of the hours needed to earn their degree because they have changed majors, is an example in which professional judgment can be used to allow additional hours to be attempted.
 - **Transfer Hours** – Hours transferred to SMU from other institutions that meet the degree plan course requirements and are accepted for transfer credit will be included in the 150% calculation.
- **Maximum Term Limits**
 - Undergraduate students are limited to 12 terms or six academic years.
 - Graduate students are limited to the time determined by the specific academic program. Information on program length can be found in the course catalog for your program of study. Maximum term limits for Doctoral programs are evaluated on a case-by-case basis with advisement from the academic department.
 - Students attending less than full time will be allowed extra terms to complete their degree.

SAP Status

- **Meets** – Students who meet the minimum standards previously mentioned are given a satisfactory status of "**Meets SAP**" and will remain eligible to receive Federal Title IV and state financial aid funding for the upcoming academic year.
- **NOT Meets** – This unsatisfactory status will be assigned to any student who does not successfully pass all required measurements for their program of study. Students failing one or more of the required measurements will be flagged as "**Not Meets SAP**" and immediately notified that they are no longer eligible to receive financial aid funding. Any financial aid offered for upcoming terms will be canceled. SAP notification is sent via SMU email. A hard copy letter may be sent as a follow up if a student has not responded.
 - The **SAP Notification** letter notifies the student that they are no longer eligible to receive Title IV funds based on the standards of satisfactory academic progress. It also explains why they are failing SAP and gives instructions on how to re-establish eligibility.
- **Approval on Appeal with Probation (APPB)** – Assigned by a financial aid adviser following a successful SAP appeal, APPB status is granted for one term only. It allows the student to receive financial aid for that term. Appeal documentation will be kept in the students file. At the end of the probationary term, SAP will be reassessed:
 - If all SAP standards are met, the student's status will be updated to "**Meets SAP**", and they will remain eligible for financial aid.
 - If standards are not met, the student becomes ineligible for aid, and the status changes to "**Disqualified**".

However, if the student shows significant academic progress, they may meet with an academic advisor and based on the advisor's evaluation submit a second appeal with a multi-term academic plan aimed at meeting SAP requirements. If approved, the status changes from APPB to APPL (Approved with an Academic Plan).

- **Approved with an Academic Plan (APPL)** – Assigned by a financial aid adviser following a successful SAP appeal, the academic plan is a multi-term agreement developed by the student and an academic adviser. It outlines a path of consistent, measurable academic improvement over multiple terms until the student meets SAP standards. SAP is evaluated at the end of each term based on the approved academic plan. Financial aid eligibility is determined on a term-by-term basis. Students who fail to show measurable progress toward meeting SAP requirements will be disqualified from receiving financial aid.
 - If the student is following the established academic plan, the student will be awarded aid for the next term.
 - If the student is not following the established agreement, the student will be allowed to appeal one more time for aid. The appeal documents will be sent electronically to the student. Aid will be offered if the appeal is approved by the Financial Aid Appeals Committee. If the appeal is denied the student will be contacted electronically by a financial aid adviser and given a detailed plan on how to regain eligibility for aid.
- **Approved per Professional Judgment (APPJ)** – Assigned by a financial aid adviser due to a successful SAP appeal. Appeal documentation will be kept in the student's file. This status is used for students enrolled in doctoral programs or during terms when students may be working on a dissertation where progression cannot be measured by GPA or Enrollment. Recommendation is given by the academic adviser.
- **Disqualified** – Assigned by a financial aid adviser when a student has exhausted all appeals and is no longer eligible to receive financial aid funds.

THE SAP APPEAL PROCESS

Students who fail any of the SAP measurements resulting in the loss of eligibility may submit an appeal for an extension of eligibility directly to Financial Aid Services. Each appeal is reviewed on a case-by-case basis. Final approval will be decided by the Appeals Committee.

Elements of an SAP Appeal

- A personal letter/email from the student to **Financial Aid Services** is required. The letter should explain the student's mitigating circumstances that prevented the student from completing the required measurements. Some examples of mitigating circumstances are student illness, family illness, other family problems, mental health challenges, interpersonal conflicts, problems adjusting to college life, balancing school and work, etc. (Financial Aid Services has the responsibility, using professional judgment, to decide if other circumstances documented by the student can be considered.)
- Signed statement from the Academic Adviser confirming they have met and discussed the SAP issue with student in developing a plan to improve academic standing. A detailed course plan, signed by the academic adviser, is required for students with a GPA of less than 1.8 and/or a completion rate of less than 70%.

Appeal Decision

- **Appeal approved** – Financial Aid Adviser will send a notification to the student via email. The student will also receive an electronic notice when their financial aid offer has been made available.
- **Appeal denied** – If the appeal is denied, a Financial Aid Adviser will notify the student via their SMU email account.

Financial Aid Services reviews all appeals before submitted to the Appeals Committee, which meets weekly and consists of various staff members within the Division of Enrollment Services.

Withdraws/Repeats/Incompletes/Failures – All hours attempted and earned will count toward the quantitative measure of 150% of hours a student may attempt when working toward a degree.

- **Course withdrawals and failures** – Hours from a course with a final grade of "W" or "F" will be included as attempted hours but not earned hours for SAP measurements.
- **Transfer hours and consortium hours** – Hours are included in attempted and earned hours. They are not counted in the cumulative GPA.

Repeated Classes and First Year Repeat – A course with a with a final grade of A, B, C, or D is considered successfully completed. A course with a final grade of F, W, or I is considered unsuccessfully completed. A successfully completed course may be repeated once when using financial aid funds to cover the course. A course that is unsuccessfully completed may be repeated no more than two times while using financial aid funds to cover the repeat hours. Once a course is successfully completed, a student can repeat the course only once and keep eligibility for financial aid funds.

Each time a course is attempted, regardless of the grade, the hours are included in the total attempted hours. Courses that are successfully completed (initial and repeat) with a passing grade are included in the total number of hours earned.

- **Grade of "F"** – Counts toward GPA and attempted hours. They will not count as earned hours and could affect the progression rate percentage.
- **Incomplete Courses** – Count toward attempted hours and if never completed, the student is assigned a failing grade. The grade of "F" counts toward GPA. Once an incomplete course is completed, the hours will count toward attempted and earned hours and GPA.
- **Summer Hours** – Count toward attempted and earned hours and GPA.
- **Pass /Fail Courses** – A passed course counts toward attempted and earned hours (but are not counted in GPA). A failed course is counted in attempted hours, but not earned hours.
- **Non-Credit or Remedial Courses** – SMU does not offer Federal Financial Aid to students who enroll in non-credit or remedial courses, or to those students who attend the University in the summer for probationary or remediation status before the first year.

Additional SMU Programs

SMU Abroad

The SMU Abroad Office serves the SMU community by developing and coordinating international programs and providing support services during and after the abroad experience. Students at SMU can participate in a wide range of January, May, summer, and semester abroad programs where they study, intern and research to build global experience and intercultural competence.

For January, May and Summer abroad programs, non-refundable commitment fees are due from each student after acceptance into a program and are payable to SMU Abroad through the online application system.

Tuition is payable to SMU Division of Enrollment Services following regular university billing procedures. Deadlines are listed by term on the Student Financial Services website at <https://www.smu.edu/EnrollmentServices/Bursar/DueDates>.

For Term-time abroad programs (Fall and Spring), a deposit is paid directly to the program provider on a deadline set by the provider. Housing is paid directly to the program provider on a deadline set by the provider.

The balance of all other tuition and fees is payable to SMU Division of Enrollment Services following regular university billing procedures and deadlines for term-time. Deadlines are listed by term on the Student Financial Services website at <https://www.smu.edu/EnrollmentServices/Bursar/DueDates>.

SMU Taos is a 423-acre SMU satellite campus on the beautiful mountains of Northern New Mexico. In this unique setting, SMU Taos provides opportunities for experiential learning and an intimate community that fosters academic and personal growth. Students can fulfill major, minor, and/or CC requirements by taking classes in Taos during focused January and summer terms. Diverse course offerings allow students of all majors to participate, with leadership programming available each summer. Students apply to the Taos program during the fall or spring term immediately preceding the Taos term and are helped with enrollment and travel preparation by the SMU-in-Taos office.

The SMU Taos program offers the same undergraduate tuition rate as the main campus. Students attending SMU Taos will pay room and meal plan rates that are competitive with those on the main campus in Dallas. Existing SMU scholarships and financial aid may apply to Taos tuition at a prorated amount. Students seeking further aid can also apply for the Friends of Taos scholarship and student worker positions. Students plan and pay for their own travel arrangements. Tuition, course fees, and room and board charges are payable to SMU Division of Enrollment Services, Student Financial Services or online at my.smu.edu. In Jan Term, students complete one course in just 8 class days; in May Term students complete one course in just 11 days. The June and July intersessions are either 11 class days or 22 class days in length. Online courses are also available in Jan Term and in the summer, each approximately one month in duration. A few courses run all summer long in a Combined 10-week session. Students may take up to 14 credit hours during the summer term but should not take more than 7 credit hours in June and 7 credit hours in July.

Whether the goal is to get ahead of the curve, explore new interests, or stay on track for graduation, Intersessions let students customize their experience and make the most of their time at SMU. Some 70 courses in a variety of subjects are offered during each of the January and May intersessions, and more than 200 courses are offered over the June and July sessions. Courses fulfill Common Curriculum (CC), major, minor, or elective requirements. Any SMU student is eligible to enroll in Intersessions through my.SMU. It may also be possible for non-SMU students to attend intersession courses after being admitted as visiting students.

Intersessions tuition comes at an added cost to Fall/Spring. No general student fees are assessed for Intersessions, though course-specific costs such as lab/studio fees or travel/accommodation fees may be associated with some courses. Most SMU merit-based and need-based financial aid is available in pro-rated amounts. Federal and state funds are not available for Jan Term and May Term but may be available for Summer.

Students living in SMU Residential Commons in both Fall and Spring terms who wish to remain on campus during Jan Term may stay in their current room at no additional charge. Students in residence and staying for May Term are eligible for on-campus housing by application, but those accepted will be moved to a single May Term commons and additional charges will apply. On-campus housing is available to any student attending June and July by application, space permitting; additional housing charges will apply. All housing arrangements and fees are administered by SMU Residence Life and Student Housing (RLSH) and SMU Dining Services.
