SMU Career Outcomes Dashboard. Career outcomes for graduates are an important measure of post-graduation success, and SMU now has a publicly available dashboard on Career Outcomes for Graduates. These outcomes do not, of course, capture the entirety of what students learn or gain from a university education, but they do tell a compelling story about how students leverage their knowledge and experience once they leave the institution. We employ multiple measures to assess student post-graduation outcomes and success. The Graduation Survey results provide detailed information on the number and percentage of graduates reporting a positive career outcome within six months of graduation, which includes full-time employment, part-time employment, acceptance into a continuing education program, military service, or volunteer service. Common Curriculum General Education Breadth Requirement

Reminders: Undergraduate students are required to complete Breadths in seven distinct areas of university study that reflect fundamental ideas and approaches associated with core academic disciplines. A minimum grade of D- is required to receive credit to satisfy each Common Curriculum Breadth requirement; however, some Breadths may be prerequisites for departmental credit and may have a higher grade requirement to continue in a sequence. It is important to nuance this distinction in communications to students when encouraging them to drop or withdraw from a class; we ask you to remind undergraduate instructors of these general education requirements. Signature Approvals Added for Teaching for Extra Compensation. For faculty who teach outside of their home unit and for staff who teach for extra compensation, signature

approvals are now required from the home unit (e.g., department chairs for faculty and immediate supervisors for staff). These changes are in response to an internal audit and will be effective immediately. A memo will go out to all academic staff who generate the extra compensation and adjunct hire forms. During the transition to this new business process, payment requests that do not contain the needed signature will be routed back through the approval process. ERISA Limits on Adjunct Teaching. The Office of Faculty Success is collaborating with HR and Payroll to generate reports that alert deans and the Provost Office when an adjunct faculty member is 3 credit hours away from reaching the ERISA limit (of 33 credit hours/year) and when they are no longer eligible to teach or to be employed without benefits. We will keep you updated on the progress of this initiative and request your input on an as-needed basis. For questions, reach out to facultysuccess@smu.edu. AY24-25 Common Curriculum Student Assessments. The Office of Institutional Planning and Effectiveness (IPE) will be collecting student assessment work in the 2024-2025 academic year for the following Common Curriculum components: Creativity and Aesthetics (CA), Historical Contexts (HC), Literary Analysis and Interpretation (LAI), Philosophical, Religious, and Ethical Inquiry (PREI), Community Engagement (CE), and Civics and Individual Ethics (CIE). Faculty teaching courses with these components from May 2024 through Spring 2025 are required to submit student work that demonstrates attainment of the skills associated with each component. Faculty will receive an email survey from the Office of Institutional Planning and Effectiveness just after add/drop to gather information about the type of assignment they are using to assess student learning. IPE will then send detailed instructions to each faculty member about how to submit their students' assessment work. All faculty teaching courses carrying Common Curriculum tags are expected to assess their students' learning in the associated components at the course level each term. Assessing these components regularly ensures that students are meeting the stated student learning outcomes and supports the continuous improvement process. Please make sure all new faculty in your departments are aware of whether their courses carry Common Curriculum components, know where to locate the Common Curriculum rubrics, and understand their responsibility to assess these components in their courses. Qwickly Attendance Platform. After reviewing the data gathered by EPR and MPR, SMU-in-Four has recommended, with input from the Faculty Steering Committee, that we pilot the Qwickly Attendance platform in the fall 2025. We are exploring ways to minimize the reliance only on Early and Mid-term Progress Reports (note—EPRs are due on February 25th). Qwickly is an attendance-tracking platform that includes Canvas LMS integration. It will initially be used for undergraduate courses and by specific lists of student-athletes. This platform will streamline attendance tracking, help ensure attendance compliance for student-athletes, and provide SMU faculty with an easy-to-use check-in system using QR codes that are also integrated with Canvas. It offers an option for faculty who have been requesting a tool that integrates easily with Canvas, and it will be a required tool for any classes that have student athletes.
